## Where to Pay or Enroll

Note: Make sure your case number is on all payments and correspondence. A failure to pay a fine, assessment, or program fee by the time the court sets, or the program rules require, could result in a revocation of probation and the imposition of a jail term. If you cannot pay or attend for some reason, you must go back to the sentencing judge before you miss a date or payment and request additional time. If payments are not made on time, the case will proceed to CIVIL ASSESSMENT or WARRANT with additional penalties added.
