The following tentative rulings shall become the ruling of the court unless a party gives notice of intention to appear as follows:

1. You must call (209) 725-4240 to notify the court of your intent to appear.

Per California Rules of Court, rule 3.1308(a)(1), failure to do both items 1 and 2 will result in no oral argument. *Note:* Notifying Court Call of your intent to appear does not satisfy the requirement of notifying the court.

Motion to Void Notice of Default

Plaintiff Sylvia Nicole's "Application to Void Notice of Default" is DENIED. Plaintiff's motion appears to seek a permanent injunction, declaratory relief, and/or cancellation of a recorded instrument. Such relief is available only after trial or other evidentiary hearing after proper notice is given to all interested parties so that they may defend against plaintiff's claims. In this case, plaintiff's motion is premature since the named defendants in this action have not appeared and have not received proper notice to allow them the opportunity to present a defense to plaintiff's claims. In addition to these fundamental procedural defects, the evidence offered by plaintiff is insufficient to prove her vague and ambiguous claims of fraud and the recording of an illegal document.

Dairy Supply Inc.'s unopposed motion to substitute the Estate of Sohan Singh Sahota as the successor-in-interest to defendant Sohan Singh Sahota, to name Bhupinder Kaur Sahota as personal representative of the Estate for purposes of this litigation, and for leave to file the proposed supplemental first amended complaint is GRANTED.
