Merced County Resources

- The Merced County Elections Office website, which can be accessed at: <u>https://www.countyofmerced.com/3632/Elections</u>, provides the hours and locations of all Voting Assistance Centers and Official Ballot Drop Box locations as well as ballot tracking and up-to-date county results.
- Voting Assistance Centers services include ballot drop-off, provisional and conditional voting, ballot replacement, accessible voting, and language services.
- The early Voting Assistance Centers are operating in Merced County starting Saturday, February 24, 2024, through Friday, March 1, 2024.
