Every litigant, including every self-represented litigant, is ordered to check the tentative ruling for their calendar matter on the day before the hearing and will be deemed to have been notified of the court's proposed ruling. Individuals who do not object to the tentative ruling, need take no further action other than that set forth in the tentative ruling.

Individuals who object to the tentative ruling or who seek to modify a proposed tentative ruling must notify the court and the other parties to the case by 4:00 p.m. on the day before the hearing and arrange to appear by CourtCall pursuant to the instructions on the tentative ruling. **Appearance by telephone is strongly encouraged.**
